_____ **TUITION FEE** We must have a credit/debit card number (Visa or Mastercard) on file for **ALL STUDENTS**. Our payment policy is as follows: ALL fees must be paid by check, cash, Visa or Mastercard **by the 7th** of the month for the current month. If payment is NOT received by the 10th your credit/debit card or checking acct will be drafted. **NO EXCEPTIONS**. If credit/debit card is declined or check is returned, participation in class will be denied until balance is brought current. Tuition can be paid at the front desk during our office hours or mailed to 428 South Buncombe Rd, Greer, SC 29650. Please keep in mind if you mail your payment, it must be received by the 7th of the month.

_____ **ANNUAL MEMBERSHIP FEE** of \$30 is non-refundable and must be paid along with the first month's tuition for **EACH** student. Your child's membership fee will be owed again **EACH** year that your child is active in Rockstar. You will receive a free Rockstar Cheer T-Shirt with your membership fee.

_____ **NSF CHARGES** \$30 NSF charge for all returned checks. Rockstar will attempt to charge credit/debit card on file for the returned check amount as well as the NSF fee of \$30.

_____ **DROPPING CLASSES** is permitted by a **MINIMUM 30 DAY WRITTEN NOTICE ONLY**. This should be given, mailed, or e-mailed to the office (phone calls or telling a coach is **not** sufficient). The office will provide you with written or emailed acknowledgement of your drop notice. You are continually enrolled in a class from month to month unless prior notice is received. **If notification is not given, you are still responsible for payment of the class.** School teams are included in this policy.

_____ **MAKE-UP CLASSES** There are **NO** refunds, discounts, or prorates if the student is absent. You will receive one Open Gym pass for each absence (no passes are given for private lessons).
